


1. Hear from Public;

6. Hear Tax Assessor/Collector's Report and take any action thereon, including
 - a. consider approving payment of tax bills;
7. Hear Delinquent Tax Attorney's Report and take any action thereon;
8. Hear Engineer's Report and take any action thereon, including:
 - a. consider authorizing Engineer to proceed with the design of District facilities;
 - b. consider approving plans and specifications of District facilities;
 - c. consider authorizing Engineer to advertise for bids for District projects;
 - d. consider authorizing construction contracts and related items; and
 - e. consider approving report, pay estimates, and change orders for construction projects in progress in the District;
9. Hear Landscape Architect's Report and take any action thereon;
10. Hear Developer's Report(s), including status of projects in District;
11. Discuss and take action on termination of contract with Storm Water Solutions;
12. Hear Maintenance Report and take any action thereon;
13. Consider approving Amendment to Contract with First Environment;
14. Hear Attorney's Report and take any action thereon, including:
 - a. consider approving extension of Flock Camera Agreement.
