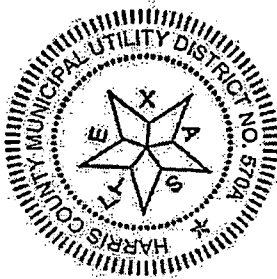
The meeting will be held on Tuesday, December 12, 2023, at 11:00 a.m.

The Board shall consider and/or act on the following matters:

1. Public Comments;
2. Review and approve minutes of the October 10, 2023 Board of Directors meeting;
3. Bookkeeper's Report, including authorizing the payment of invoices presented;
4. Approval of Resolution Authorizing Participation in Texas Cooperative Liquid Asset Securities;
5. Tax Assessor-Collector's Report;
6. Appointment of Tax Assessor-Collector as agent of the District relative to providing Notice to Purchaser forms and establishment of a fee to be charged in connection therewith and the adoption of a Resolution in connection therewith;
7. Ratify approval of Acknowledgement of Notice and Indemnity from Trez Capital (2015) Corporation to Trez Capital (2018) Nominee LP;
8. Operator's Report;
9. Developer's Report;
10. Engineering Report, including:
  - a. Authorize or ratify the design, advertisement for bids and/or award of construction contracts or concurrence in the award of contracts for the construction of facilities within the District, and authorize acceptance of Texas Ethics Commission ("TEC") Form 1295;
  - b. Review and approval of any storm water plans, permits and/or affidavits related to construction within or on behalf of the District, and the execution of any documentation in connection therewith;

  - e. Acceptance of facilities for operation and maintenance purposes, site and/or easement conveyances for facilities constructed or to be constructed for the District, and acceptance of any related storm water plans and/or permits;
