
1. Call to order and invocation.

5. Consideration and possible action on matters pertaining to grants and other funding available from the state, federal government, or other sources.
6. Consideration and possible action regarding requisition requests, repairs or replacements of equipment, supplies, materials, vehicles, and apparatus, including ratification and approval of prior purchases of less than \$2,000.00 by authorized persons.
7. Consideration and possible action in connection with purchase of four WolfCom body cameras for \$2,646.00.
8. Consideration and possible action in connection with purchase of two McGrath Video Laryngoscopes for \$4,157.79.
9. Consideration and possible action in connection with purchase of two XL-185P Portable Radios and Vehicle chargers, together with accessories, per the December 4, 2023, quotation from Dailey & Wells Communications, Inc.
