## HARRIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 490 NOTICE OF PUBLIC MEETING

Notice is hereby given to all interested members of the public that the Board of Directors of the above captioned District will hold a regular meeting at 1300 Post Oak Boulevard, Suite 1400, Houston, Harris County, Texas, 77056, said address being a meeting place of the District.

The meeting will be held on Thursday, October 28, 2021 at 12:00 Noon.

The Board shall consider and discuss the following matters and take any action appropriate with respect to such matters:
